The school undertakes toabide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- That the school will ensure compliance of all statutory requirements like EPF, ESIand Labour Laws etc. with respect to the school and staff of the school.
- That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concernedmunicipal or state authorities from time to time as per the prescribed term.
- That the school will ensure that all required infrastructure is available with theschool before starting classes. 10.
